A special meeting for opening of the Bids on the Pedestrian Streetscape Improvement project was held on Thursday October 20, 2016 at the Town Hall at 11:03 am with the following members:

A total of 4 four bids were received.

Edmund Snyder indicated that a budget of \$862,790.00 was available for the project.
